#### MINUTES OF TRUSTEES MEETING June 26, 2018

#### 1. CONVENING

A meeting of the Board of Trustees of Berkshire Community College was held on Tuesday, June 26, 2018, at the South County Center. Board Chair Rodowicz called the meeting to order at 4:12 pm.

#### 2. APPROVAL OF THE MINUTES

Upon a motion duly made and seconded, it was VOTED unanimously to approve the minutes of the April 24, 2018 meeting.

#### 3. PRESIDENT'S REPORT

#### a. New Employee Introductions

Vice President Klepetar introduced George Ambriz, BCC's new Director of Academic and Career Advising. George spoke about his aspirations, his family and how happy he was to be at BCC.

#### b. Nursing Program 50 Years

Dr. Tochi Ubani, who assumed leadership of both the ADN and LPN Nursing Programs in November 2015 made a presentation to the Board. The programs were consolidated to reflect the mission and vision of BCC. Curricula was aligned to meet approval and accreditation standards.

In 2016, Massachusetts Board of Registration in Nursing (MABORN) granted the ADN program full approval. Accreditation Commission for Education in Nursing (ACEN) granted the ADN program continuing accreditation with conditions for non-compliance in Standard 4 (Curriculum) and Standard 6 (Outcomes). Standard 4 is currently approved.

Also, in 2016, MABORN required a focused LPN program review and report due by June 12, 2016. MABORN accepted the report and granted full approval to the LPN program.

#### ADN Program

- o Granted ACEN accreditation with conditions in 2015
- Granted ACEN accreditation with warning for good cause in 2018
- o ACEN Remediation Report is due in early fall
- ACEN site visit in late October

#### Challenges:

- o Culture lacks understanding for the role of nursing leadership
- o Program lacks consistent review of Systematic Evaluation Plan
- Nursing curricula must consistently incorporate professional standards, guidelines, and competencies
- End-of-Program Student Learning Outcomes must be clearly articulated and must be consistent with contemporary practice
- o Student-centered focus on learning outcomes to reduce attrition rate
- o Admission and progression must be updated to reflect best practices
- BCC Nursing must be recognized as a prominent program/department within the college and region

# Goals and Next Steps:

- ADN Remediation report on Standard 6 (Outcomes) due by August 1, 2018
- LPN Program projects ACEN initial accreditation by 2023, self-study report to be submitted in 2020
- Anticipated MABORN continued approval for both ADN and LPN programs
- Increase enrollment in ADN program by 9 students for fall 2019 and 18 students for fall 2020
- Increase enrollment in LPN program by 9 students for fall 2019 and 18 students for fall 2020
- Change nursing curricula to reflect 3 credit nursing courses instead of current 8-9 credits

Discussion was had around the topics of demand, applicant numbers, length of time for completion, and completion rates.

# 5. FOUNDATION BOARD TRUSTEE REPORT

Lori Gazzillo reported the following:

- Forty students registered for South County Center Adult Learning Program. The program budget was reduced by the state.
- o \$50,000 from the annual fund was given to close the gap on the turf field project
- Next year's budget was approved, level funded
- Assets stand at about \$11 million
- Audit is underway
- o Investment review was completed and the Investment Committee is satisfied with performance
- o Foundation gave out \$315,000 in scholarships to 175 students
- \$50,000 in scholarships for new students, recruiting and helping those for whom finances are a major obstacle
- 40 Under Forty was a great event, plan to do it again next year

New Programs/Courses

Academic Affairs Offices

Jennifer Berne, the incoming VPAA and Laura Saldarini will be moving down the hall from the current VPAA offices.

#### Community Education and Workforce Development Department Overview

ABE/ESOL Program

Loss of funding at the state level for this program will bring the number of ESOL students served from 91 this year to 54 next year. If funding can't be reinstated, the hope is to make this a transition year and find another provider to host this program in the future. Currently the program serves students in Great Barrington and Lee with a separate program running in Pittsfield.

Berkshire Innovation Center (BIC)

On June 24th, BCC hosted the BIC Programming Committee Kick-Off meeting. Full funding has been acquired. The plan is to hire an executive director by the fall. Eventually, BCC's workforce development department will have offices in the new facility. BCC has been partnering with the BIC since 2015 offering the following:

- BIC equipment training
- o BIC Speaker Series/Training Programs
- Customized Training
- Basic Manufacturing Skills
- On-Line Manufacturing Certifications
- Advanced Manufacturing Certificate and Degree programs
- BIC is now taking on the Berkshire Robotics Challenge (BIC-branded activity, hope to run the competition at the BIC in the future).
- Move to Campus and Framework Membership

At the end of this summer, the Workforce Development and Community Education offices, currently located at the Conte Federal Building, will move its operations to the main campus. The exact location on the main campus is unknown at this time. There are four employees who work in these departments that will be affected by this relocation to main campus – Director of Corporate Training Denise Johns, Director of Community Education Linda Morelli, Assistant to the Dean Christine Hoyt, and part-time Clerk III Kirsten Wanamaker. In addition, BCC will enter into a membership agreement with Framework, a co-working space on North Street. Beginning in July, this partnership will allow BCC to maintain a downtown presence as well as have office space for meetings and other collaborations.

Kid Academy STEAM Program

Thanks to a grant from the Mertz Gilmore Foundation, BCC is hosting the Kid Academy STEAM Program for three separate one-week sessions in July and August. 24 students from each of the eight Pittsfield Elementary Schools, will be chosen to attend.

  - During the summer months, the Board of Trustees is exempt from meeting under state law. In order to maintain the continuity of operations, delegation of the Board's authority is granted to the President for the summer months. Pursuant to Massachusetts General Laws, Chapter 15A, Section 22, the Board of Trustees of Berkshire Community College has exclusive authority and responsibility for establishing those policies necessary for the administrative management of personnel, staff services and the general business of the College. Furthermore, pursuant to Section 22 of Chapter 15A, the Board of Trustees may delegate to the President of its institution any of the powers and responsibilities specifically enumerated therein.

Upon a motion duly made and seconded, it was VOTED unanimously to designate the delegation of Board Authority to President Ellen Kennedy beginning June 26, 2018 until the first formal Board meeting on August 28, 2018 and the President agrees to consult with the Chair or Vice Chair of the Board when using the summer delegation of Authority for personnel matters and other related business.
